# A Bill to Ban Underage Circumcision

#### 1 BE IT ENACTED BY THIS CONGRESS THAT:

2	Article I:	All circumcisions performed on male children below the legal age of
3		consent shall be illegal and unlawful. Religious exemptions will not be
4		allowed as the child may choose their religion at the legal age of consent.
5	Article II:	"Age of consent" refers to the age of 18 years old. "Circumcision" refers
6		to the surgical removal of the foreskin of the penis or prepuce. "Child
7		abuse" is when a parent or caregiver, whether through action or failing to
8		act, causes injury, death, emotional harm or risk of serious harm to a child.
9		"Child neglect" is a deficit in meeting a child's basic needs, including the
10		failure to provide adequate supervision, health care, clothing, or housing,
11		as well as other physical, emotional, social, educational, and safety needs.
12	Article III:	This bill will become effective on January 1, 2021.
13	Article IV:	The U.S. Department of Social Services will oversee implementation of
14		this law and treat cases of circumcision as physical child abuse. The act of
15		performing a circumcision will be legally addressed as child abuse, and
16		will be punished according to the laws of the state in which the crime was
17		committed. The act of allowing a child to undergo a circumcision will be
18		seen as child neglect, and will be punished according to the laws of the
19		state in which the crimes were committed.
20	Article V.	Any laws or statutes in conflict with the bill are considered null and void.
