4		for a minimum of 2 years. US Citizens who fail to comply will receive a			
5		mandatory minimum sentence of 3 years in the federal penitentiary.			
6	Article II:	US Citizen will be defined as any male aged 18 that is physically able			
7		bodied enough to serve. Armed Forces is defined as either the United			
8		States Army, Marine Corps, Navy, or Air Force			
9	Article III:	This bill will become effective June 1st, 2024.			
10	Article IV:	The United States Department of Defense will be responsible for the			
11		enforcement of this bill.			
12	Article V:	All other laws that are in conflict with this new policy shall hereby be			
13		declared null and void.

## A Bill to Exclude Non-Citizens from the Census

1	Be it enacted by this Palm Beach Catholic Forensic League Student Congress here				
2	assembled that:				
3	Article I	Only individuals who are considered United States citizens may be			
4		counted by the United States Census Bureau toward official redistricting			
5		data.			
6	Article II.	"Citizens" are legally recognized subjects of a state or commonwealth,			
7		either native or naturalized.			
8		A. Individuals considered non-citizen legal residents, non-citizen			
9		long-term visitors, or undocumented immigrants are to be excluded			
10		from the official Census.			
11	Article III.	This bill shall take effect prior to the 2030 United States Census.			
12	Article IV	The United States Bureau of the Census (which is a part of the United			
13		States Department of Commerce) will oversee the enforcement of this			
14		bill.			
15	Article V.	All laws in conflict with this legislation are hereby declared null and void.
