

A Bill to Aid the Kurds

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: \$1 billion of military aid will be given to the Syrian Kurds for the
4 purpose of defending against Turkish Aggression. In conjunction, a
5 no-fly zone will be established over the Kurdish enclave in Syria.

6 Article II: “Military aid” shall be defined as money intended for weapons and
7 military infrastructure. A “no-fly zone” shall be defined as an area
8 where aircrafts cannot fly. The “Kurdish enclave in Syria” shall be
9 defined and drawn by the Department of State.

10 Article III: This legislation will take effect on January 1, 2022.

11 Article IV: The Departments of Defense and State along with USAID will
12 along with the specific enforcement mechanism.

13 A) The Departments of Defense and State will advise Kurdish
14 leaders on how to use the aid.

15 B) The no-fly zone will be in place for at least 3 years. Each year
16 after that, the Department of Defense will review whether or not
17 to keep it in place.

18 Article V: All other laws in conflict with this new policy shall be null and void.

A Bill to Create a Committee of Citizens to Fairly Distribute Infrastructure Funding

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 **Article I.** A committee of elected citizens will be created for the purpose of
4 reallocating infrastructure funding.

5 A. Committees will be created on the local, state, and regional levels.

6 B. The elections for this committee will be held at the same time as
7 the general elections take place.

8 **Article II.** Infrastructure shall be defined as the basic systems and services that a
9 country uses in order to work effectively.

10 **Article III.** This legislation will take effect on January 1, 2021

11 **Article IV.** The Department of Justice will oversee the implementation of this
12 legislation.

13 A. The Department of Justice shall allocate an extra \$1 billion to local
14 police departments in order to compensate for the cost of body
15 cameras and storage systems for visual and audio recordings.

16 B. Any department found not to be complying with this legislation
17 shall have their funding cut by 35%, increasing by 10% for every
18 month the department is found not to be in compliance.

19 **Article V.** All laws in conflict with this legislation are hereby declared null and void.

14 hereby be declared null and void.

A Bill to Allow Immunity Cards in Place of Vaccination Card.

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 **Article I:** Antibody levels may be used in place of vaccine cards for individuals
4 who have recovered from Covid and otherwise unable to get the vaccine.

5 **Article II:** A. Antibody or serology levels will be determined through a cPass SARS-CoV-
6 Neutralization Antibody Detection Kit.

7 B. Acceptable levels of IgM and IgG antibodies must be shown
8 up to six months from date of card.

9 C. “Unable to get the vaccine” include people previously exposed to
10 COVID and within the months that are discouraged from vaccine, those
11 with religious exemptions, and those who are immunocompromised.

12 **Article III:** This legislation will be enacted in January, 2022

13 **Article IV:** The Center for Disease Control, along with the Food and Drug Administration,
14 will be in charge of implementation

15 **Article V:** All other laws that are in conflict with this new policy shall hereby be
16 declared null and void.

15 **Article IV:** The United States Department of Justice will oversee implementation of
16 this Legislation.

17 **Article V:** All laws in conflict with this Legislation shall be declared null and void.

3 Article I: The United States shall implement a federal cybersecurity system

10 October 2022.

11 **Article IV:** Both the Department of State and the Department of Commerce will
12 would enforce this bill.

13 A) Sanctions upon those Chinese Communist party officials

14 B) United States - Chinese trade would be prohibited

15 **Article V:** All other laws in conflict with this will be declared null and void.

The Lithium and Cobalt Importation Tariff Act (LCIT Act)

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 **Article I:** Imports of Lithium and Cobalt shall have a tariff place upon these good at
4 the rate of 10% of the goods' market value. The money shall be allocated
5 towards road construction and highway maintenance.

6 **Article II:** A. Lithium and Cobalt shall be defined as key elements used in the
7 production and construction of electric vehicles and their batteries

8 B. Market Value shall be defined as the value of importation costs

9 C. Construction and highway maintenance shall be defined as
10 additional support towards the sustenance and longevity of public
11 vehicular based infrastructure.

12 **Article III:** This piece of legislation shall be implemented once the amount of electric
13 vehicles supersedes the amount of gas-based vehicles produced

14 **Article IV:** The Department of Transportation shall monitor the number of gas-based
15 vehicles versus electric-based vehicles and allocate resources toward
16 crumbling roads and highways. The U.S. Customs and Border Protection
17 shall oversee the implementation of tariffs.

18 **Article V:** State that all other laws that are in conflict with this new policy shall hereby
19 be declared null and void.

**A Bill to Implement a Cap and Trade System in the Oil Industry to Combat
Global Warming**

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 **Article I:** The United States will implement a cap and trade system limiting the total
4 CO₂ emitted from the burning of fossil fuels in the united states starting
5 with a limit of 4.5 billion tons.

6 **Article II:** Cap and Trade shall be defined as a government regulatory program
7 designed to limit, or cap, the total level of emissions of certain chemicals,
8 particularly carbon dioxide and allowing for a free market in which
9 pollution permits can be sold.

10 Security shall be defined as a tradable financial asset.

11 **Article III:** This law shall become effective January 1, 2024.

12 **Article IV:** The US Federal Trade Commission (FTC) will oversee the fulfillment of
13 permits. The Securities and Exchange Commission (SEC) will oversee the
14 distribution of the permits and the transfer of permits as securities and the
15 Internal Revenue Service (IRS) will oversee the Cap and Trade Dividend
16 A) Permits will be sold annually at public auctions open to both corporations
17 and private Individuals. Pollution permits will expire 5 years after distribution.
18 B) The total Cap will decrease 5 percent Annually for the next 10 years.
19 C) All money raised be distributed equally among all United States Citizens

20 **Article V:** All other laws that are in conflict with this new policy shall hereby be
21 declared null and void.

A Bill to Solve America’s Housing Shortage

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 **Article I:** \$150 billion will be allocated to build new public and affordable housing
4 for homeless individuals. Public housing shall be provided for a minimum
5 of one year, after which impacted families will be moved to affordable
6 housing requiring rent payments, based on income limits set by the U.S.
7 Department of Housing and Urban Development (HUD).

8 **Article II:** “Public housing” is housing provided for people with low incomes,
9 subsidized by public funds. Affordable housing is defined by HUD as
10 housing on which the occupant is paying no more than 30 percent of gross
11 income for housing costs, including utilities. Homeless is defined as
12 individuals who lack a fixed, regular, and adequate nighttime residence,
13 and/or if they sleep in a shelter designated for temporary living
14 accommodations or in places not designated for human habitation.

15 **Article III:** This legislation will go into effect January 1, 2023.

16 **Article IV:** HUD will oversee all aspects of this legislation, including allocating and
17 distributing funds, and development of housing options in conjunction
18 with the individual states.

19 **Article V:** All other laws in conflict with this new policy shall be null and void.

A Bill to Abolish Federal Private Prisons

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 **Article I:** All private prison complexes shall have their federal government contracts
4 terminated and all pecuniary funding shall cease. Failure to be in
5 compliance with this bill and continuation of operation shall result in legal
6 action.

7 **Article II:** A) Private prisons shall be defined as any prison that is owned by a
8 third-party organization contracted by a government agency and aims to
9 make money.

10 B) Abolish shall be defined as the end of use and funding.

11 C) Pecuniary funding shall be defined as any money that is presented
12 through any method of funding from the federal government.

13 D) Failure to be in compliance with this bill shall be defined as continued
14 use of federal private prisons.

15 E) Legal action shall be defined as government officials going to the site of
16 continuation and forcing a closure, thus resulting in a fine of
17 \$100,000,000.

18 **Article III:** This bill shall go into effect on January 1, 2023.

19 **Article IV:** The Federal Bureau of Prisons shall oversee the enforcement of this bill

20 **Article V:** All other laws in conflict with this new policy shall be null and void.
