

The C.A.T. (Curb Asian Tensions) Act of 2026

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: The United States shall improve military connections with its allies, Japan
4 and Australia, in order to deter further Chinese and North Korean
5 expansion and control of the South China Sea.

6 A. We will fund 100 million dollars to the Australian navy to increase
7 the manufacturing of warships and nuclear submarines.

8 B. We will fund 5 billion dollars to pay for the expansion of Japanese
9 artificial islands in the South China Sea.

10 Article II: Artificial Islands, for the purpose of this legislation, will be defined as
11 islands created by the Japanese government that house military troops.

12 Nuclear submarines will be defined as vessels that have the capability to
13 store and fire nuclear weapons.

14 Article III: This legislation will take effect June 1, 2026.

15 Article IV: The Department of Defense will oversee the implementation of this
16 legislation.

17 Article V: All other laws in conflict with this new policy shall be null and void.

A Bill to Make Higher Education More Affordable

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress

2 here assembled that:

3 Article I: To make Higher Education More Affordable, more citizens would
4 be able to receive a college education. A government mandated sales tax
5 of 7.00% will be charged on all consumer products in all
6 sales tax of 7.00% will be charged on all consumer products in all

A Bill to Ban Members of Congress from Trading Stock

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: The trading and holding of all stocks by active members of Congress and
4 their immediate family will be banned. All active Congress members must
5 put their stocks into a blind trust, sell, or buy-to-cover their stocks before
6 this bill goes into effect.

7 Article II: A) Trading stock: the buying and selling of shares in companies to try
8 to make money on price changes.

9 B) Immediate family: spouses and children.

10 C) Blind trust: a financial arrangement where a person in public
11 office gives the administration of private business interests to an
12 independent trust in order to prevent conflict of interest.

13 D) Buy-to-cover: buying back to close out an existing short position.

14 Article III: This bill will go into effect on January 1, 2025.

15 Article IV: The Securities and Exchange Commission will oversee the enforcement of
16 this bill.

17 A) Once a member of Congress leaves, they shall be allowed to buy
18 and sell stocks again.

19 B) Failure to meet the deadline will result in a fine up to 25% of
20 annual salary.

21 Article V: All other laws in conflict with this new policy shall be null and void.

A Bill to Achieve Strategic Independence

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: The United States shall levy an additional 15% import tax on strategically
4 important goods imported from other countries.

5 Article II: \$100 billion shall be made available to the Department of State to
6 distribute in grants and subsidies to companies involved in the domestic
7 production of strategically important goods.

8 Article III: Strategically important goods shall be defined as the following:

9 A. Semiconductors;

10 B. Transistors;

11 C. Rare-earth elements;

12 D. Lithium-ion batteries

13 E. Pharmaceuticals;

14 F. Personal protective equipment (PPE);

15 G. The chemical butanetriol.

16 Article IV: The United States Department of State will oversee the implementation of
17 this bill.

18 Article V: This bill shall take effect at the start of FY 2025. All laws in conflict with
19 this legislation are hereby declared null and void.

A Bill to Require Pre-Nuptial Agreements for all Federally Recognized Marriages

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here

2 assembled that:

3 Article I: All federally recognized marriages are required to have a legally recog-
4 nized Pre-Nuptial Agreement in advance of the ceremony.

5 Article II: Pre-Nuptial Agreement is defined as, “agreements made by a couple bef-
6 fore they marry concerning the ownership of their respective assets
7 should the marriage fail.”

8 Article III: Each US State will be responsible for Implementation of the Legislation.

9 Each State’s Marriage Registry will not certify a marriage without proper
10 documentation of a Pre-Nuptial Agreement.

11 All documentation will be turned over to the IRS for tax documentation

12 Prospective Couples whose individual income is less than 15% above their

13 county poverty line will be entitled to free legal counsel for creation of the

14 Pre-Nuptial Agreement – funded through the taxes of the state’s choice

15 Article IV: All Marriages Legally Recognized through January 20th 2025 will be

16 exempt from this new law. All marriages as of January 21st 2025 must be

17 in accordance with this legislation

18 Marriages not in compliance will not be Federally Recognized, which

19 results in couples being unable to file jointly for their tax return

20 Article V: All other laws in conflict with this new policy shall be null and void.

Foreign Agent Restrictive Measures (F.A.R.M.) Act

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article 1 Land owned by foreign investors will be prohibited in areas within a 10
4 square mile radius of military installations. Currently owned land that
5 defies this bill has 1 year to resell to domestic investors or such land will
6 be taken by the government through eminent domain.

7 Article 2 Foreign investors will be defined as any foreign entity operating
8 principally or registered beyond the borders of the United States.

9 Article 3 The United States Department of Defense (USDoD) and United State
10 Department of Interior (USDoI) in coordination with the Office of the
11 Director of National Intelligence (ODNI) will oversee the implementation
12 of this bill.

13 A) Any agency or bureau under the ODNI may be given authority to
14 oversee the tracking of land ownership of this bill as necessary.

15 B) If Eminent Domain is to be enacted, it will be overseen by
16 the Departments of Defense and Interior for the purpose of setting
17 up secure perimeters around military facilities.

18 Article 4 This legislation will take effect on January 1, 2025

19 Article 5 All laws in conflict with this legislation are hereby declared null and void.

The Energy Independence Act of 2024

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress
2 here assembled that:

3 Article 1: The United States shall hereby aid in the usage of fossil fuels in the
4 following ways:

5 A. 75 billion dollars shall be allocated for the building
6 of new oil refineries, oil wells, and natural gas production
7 facilities.

8 B. 25 Billion dollars shall be allocated to already existing oil
9 and natural gas plants in the U.S. for modernization and
10 increasing efficiency of said plants.

11 Article 2: Oil wells and natural gas fracking plant will be defined as a
12 site the pulls oil or natural gas out of the ground or sea floor for the
13 purpose of energy production. Oil refineries will be defined as a
14 site with purpose of turning crude oil into useable oil products like
15 gasoline and motor oil.

16 Article 3: The Department of Energy in conjunction with the United States
17 Treasury shall oversee the implementation and enforcement of this
18 legislation.

19 Article 4: This bill will go into effect upon the date of January 1st, 2024.

20 Article 5: All laws in conflict with this legislation are hereby declared null
21 and void.

The West African Stability Act of 2023

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article 1: Mohamed Bazoum is recognized as the legitimate President of Niger

4 Article 2: A fund for the restored Republic of Niger is established and funded with
5 an initial amount totaling \$600 million dollars, which is to be sourced
6 from \$233 million in current aid to Niger, and \$367 million in current mili-
7 tary aid to Egypt

8 Article 3: \$10 billion in military aid is to be distributed among ECOWAS (Eco
9 nomic Community of West Africa) partners and Nigerien forces loyal to
10 President Bazoum for the purpose of improving relations, modernization
11 and attaining combat readiness.

12 Article 4: The Nigerien Fund is to be overseen and implemented by the Office of
13 Foreign Assets Control (OFAC) of the Treasury Department, and military
14 aid is to be administered by the Department of Defense.

15 A) All military aid is to be sourced from discretionary funding.

16 B) The fund for the restored Republic of Niger is solely for humani-
17 tarian purposes and is not to be accessed by the CNSP (National
18 Council for the Safeguard of the Homeland), the junta in de facto
19 control of Niger.

20 C) ECOWAS partners currently consist of Nigeria, Ghana, Senegal,
21 Liberia, Cape Verde, The Ivory Coast, Togo, Benin, Sierra Leone,
22 Guinea Bissau, and the Gambia.

23 D) Aid for ECOWAS and forces loyal to Bazoum is to be divided
24 proportionally by the Department of Defense, and is not open to
25 suspended members of the regional bloc.

26 Article 5: This legislation will take effect no earlier than April 24th, 2024 and no
27 later than September 24th, 2024, the beginning of the next fiscal period.

A Bill to Protect Children Working in the Entertainment Industry

1 Be it enacted by the Palm Beach County School District here

11 Article IV: The Department of Labor shall be charged with overseeing the
12 the implementation of this legislation.

13 Article V: All other laws in conflict with this new policy shall be null and void.

THE TECHNICAL SERVICE PROVIDERS (TSP) ACT

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: The Food Security Act of 1985 shall be amended to streamline and
4 simplify the process for obtaining Technical Service Provider (TSP)
5 licenses, with the aim of enhancing accessibility for interested individuals.

6 Article II: The modifications in Article I shall include the reduction of bureaucratic
7 barriers, expediting the approval process, and ensuring that eligibility
8 criteria are clear and reasonable.

9 Article III: This bill will become effective 90 days after its enactment.

10 Article IV: The United States Department of Agriculture shall work alongside state
11 and local governments to oversee the passing of this legislation.

13 Article V: All other laws in conflict with this new policy shall be null and void.

3 Article I: All federally recognized Native American reservations will no longer
4 be owned or controlled by the Federal Government.

5 Article II: A Native American reservation will be defined as a self-governing
6 entity, separate from the state that the land is currently in, which is
7 controlled by a federally recognized tribe(s).

8 Article III: The bill will go into effect on January 1, 2026.

9 Article IV: The Department of the Interior and The Bureau of Indian Affairs will
10 oversee the implementation and enforcement of this bill.

11 A) All federally controlled native reservations will become the private
12 property of the tribe as an organization.

13 B) All land held in "trusts" by the federal government for native tribes
14 will also become the property of the tribe(s) as an organization.

15 Article V: All other laws in conflict with this new policy shall be null and void.

A Bill to Transition the United States to a True Anarcho-Communist State

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress
2 here assembled that:

3 Article 1 The United States of America shall hereby abandon liberal democracy and

16 established by the Coinage Act of 1792.

17 Private property refers to the criminal act of designation for the ownership
18 of property by non-governmental legal entities.

19 Article 3 Due to the abolishment of the US executive branch, no executive branch
20 shall be allowed to oversee this legislation. No enforcement is needed.
21 They're all gone.

22 Article 4 This legislation will take effect immediately upon passage.

23 Article 5 All laws and constitutions in conflict with this legislation are hereby
24 declared null and void.
