2	Section 1.	The government will subsidize the purchase of automobiles by		
3		applicants living under 225% of the Federal Poverty Line. Each		
4		applicant must be licensed to drive and must be able to show a		
5		significant need for a vehicle by submitting an application to		
6		the Department of Health and Human Services.		
7	Section 2.	"Subsidize" is financial support to cover 75% of an automobile's		
8		initial cost. The "Federal Poverty Line" is the measure of income		
9		calculated by the Department of Health and Human Services to		
10		determine eligibility for Medicaid and other programs.		
12	Section 3.	The Department of Health and Human Services will be tasked		
13		to create an application including the finances of the applicant,		
14		the need for a vehicle, and the applicant's ability to drive to		
15		earn this subsidy. The Department of Health and Human		
16		Services will receive \$5 billion annually to assist in paying for		
17		the vehicles.		
18	Section 4.	This legislation will go into effect in the FY 2022.

# A BILL TO ESTABLISH EMPLOYMENT OPPORTUNITIES FOR U.S. WAR VETERANS

1	BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:	
2	Section 1:	This bill will establish employment opportunities for able-bodied
3		United States war veterans. This would create jobs for retired war
4		veterans after they return from over sea conflicts and assignments.
5	Section 2:	This would allow for some 1 million unemployed war veterans back in
6		the economy and back to work. Types of jobs include Firemen and
7		Police officers. These new jobs will promote a veteran's self-worth by
8		allowing for a return to a productive use of their time and by
9		decreasing the percentage of post-war psychological issues.
10	Section 3:	The Department of Labor and the U.S. Departments of Veteran Affairs
11		will execute and carry out all party of this bill upon passage.
12	Section 4:	This bill shall go into effect 120 days after passage.
13	Section 5:	All other laws that come into conflict with this new policy shall hereby
14		be declared null and void.
