

A Bill to Promote and Support Infant Industries Based in the United States

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Section I: The policy provides protectionist barriers, tax incentives, and
4 federal grants to US corporations that expand into critical industries
5 in order to increase their market share and production capacity and
6 to keep them in the United States as long as it serves our national interest

7 Section II: Industries that produce intellectual property, cooperate with US
8 national security interests, and seek to achieve global competitiveness in
9 its sector by proving export orders.

10 Section III: Law will go into effect January 1st 2025

11 Section IV: The actions will be managed by the Federal Reserve that will allocate
12 a yearly sum of 60 billion dollars to achieve these aims

13 A) Funds will be given through the use of categorical grants

14 B) Any violations will be prosecuted by the DOJ

15 C) Any foreign enterprise that seeks to relocate its headquarters to the
16 US will be subject to the same terms as detail in the bill

17 Section V: All other laws in conflict with this new policy shall be null and void.

A Bill to Remove Arabia’s Foreign Firearms and Intelligence to Negate the Endless Neglect of Groups in Operations (The R.A.F.F.I.N.E.N.G.O. Act)

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States will no longer sell offensive arms or provide
3 offensive intelligence to Saudi Arabia

4 **SECTION 2.** Offensive arms shall be defined as any instrument of war that can
5 be used in an offensive manner, with the intent to harm
6 individuals. Intelligence shall be defined as any information that
7 can be used to support offensive war efforts in any way.

8 **SECTION 3.** The Department of Defense shall oversee the implementation of
9 this bill.

10 **SECTION 4.** This legislation will take effect immediately after passage.

11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null
12 and void.

A Bill to Ban Food Colors Linked with Health Defects

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The use of food colorings that are linked with health defects, such
3 as Attention Deficit Hyperactive Disorder (ADHD) and allergen
4 based health concerns, shall be banned in U.S. foods, drinks, and
5 other ingestible goods.

6 **SECTION 2.** Food colorings with health concerns include red dye #40, blue dye
7 #2, yellow dye #5 (Tartrazine), and yellow dye #6 (Sunset
8 Yellow). Allergen based health concerns include migraines, hives,
9 and bodily swelling.

10 **SECTION 3.** The Food and Drug Administration (FDA) shall oversee the
11 implementation and enforcement of this legislation.

12 **SECTION 4.** This legislation shall be implemented on January 1st, 2022, and
13 food production companies shall be given until September 1st 2022
14 to halt the use of these dyes in their product.

8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null
9 and void.
