

## **The Refugee Placement Act of 2021**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 Section 1. The Executive Branch of the United States shall have the authority  
3 to place accepted refugees in any location under the jurisdiction of  
4 United States.

5 Section 2. No state or local government shall have the authority to reject or  
6 protest refugees placed within their jurisdictions as a result of this  
7 Act.

8 Section 3. The Department of Homeland Security shall be tasked with  
9 ensuring that all accepted refugees are properly vetted. This Act  
10 shall be enforced by the Department of Justice, which shall have  
11 the authority to determine and assign penalties for violations

12 Section 4. This Act will take effect immediately upon passage.

13 Section 5. All laws in conflict with this legislation are hereby declared null  
14 and void.

**A Bill to Establish a Strong Military Presence in Saudi Arabia to  
Protect U.S. Interests in the Middle East**

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2. Section 1: A. The United States will send 1,000 troops to the Prince Sultan Air Base
3. in Saudi Arabia.
4. B. The United States will also send its fighter jets to fly missions over Iraq
5. and Syria on a weekly basis.
6. C. The relocation of troops and fighter jets will be accompanied by \$100
7. million in military aid for the refurbishment of the Prince Sultan Air Base
8. and \$500 million dollars in military aid to the Saudi government.
9. Section 2: A. Military aid shall be defined as money intended for weapons, military
10. infrastructure.
11. Section 3: This bill will be implemented on March 1st, 2021.
12. Section 4: A. The Department of Defense will oversee the implementation and
13. enforcement of this legislation.
14. B. CENTCOM will oversee the air patrol conducted by the fighter jets.
15. Section 5: All laws in conflict with this legislation are hereby declared null and void.

## **A Bill To Expand The Visa Program**

1       BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2       Section 1:     The United States shall expand H-1B Visa issuance by 10,000 annually  
3                     until 2025. The United States shall expand H-2B Visa issuance by 5,000  
4                     annually until 2023.

5       Section 2:     A. H-1B Visas shall be defined as a temporary visa that employers use to  
6                     hire foreigners in “specialty occupations”.

7                     B. H-2B Visas shall be defined as a temporary visa that allows 10  
8                     foreigners to come to the United States and perform nonagricultural  
9                     services or labor.

10      Section 3:     The Department of State in conjunction with the United States Citizenship  
11                     and Immigration Services shall be in charge with implementation.

12      Section 4:     This legislation shall go into effect July 1, 2021

13      Section 5:     All laws in conflict with this legislation are hereby declared null  
14                     and void.

**A Bill to Require Automatic Registration to  
Decrease Voter Suppression**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 Section 1. Section 8(A)(1) of the National Voter Registration Act will be amended to  
3 read, “ensure that any eligible resident is registered to vote in an election.”

4 Any section outlining an application or filling in order to obtain a  
5 registration will be struck.

6 Section 2. Eligible resident will mean any person who is over 18 years old, retains  
7 citizenship in the United States and respective state, and is not actively  
8 incarcerated, or is not actively subject to any pains and penalties that result  
9 from criminal liability per the findings of a Court.

10 Section 3. This legislation will be enforced by the Federal Election Commission in  
11 conjunction with State and Local election authorities.

12 A. If any State, agency or official fails to comply or enforce this  
13 legislation, the Attorney General of the United States may bring  
14 civil action in a respective district court for declaratory or  
15 injunctive relief necessary to comply with this Act.

16 Section 4. This legislation will go into effect January 1, 2021

17 Section 5. All laws in conflict with this legislation are hereby declared null and void.

## **A Bill to Improve American Infrastructure**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 Section 1. The United States shall take a multipronged approach to fix  
3 its faulty infrastructure.

4 A) \$250 billion will be set aside to repair failing roads and bridges.

5 B) The US tax on gasoline will rise to 30 cents per gallon of gas.

6 C) The US tax on diesel will rise to 35 cents per gallon of diesel.

7 Section 2. Failing roads and bridges shall be defined as any road or bridge  
8 deemed to be in poor condition and/or having deteriorated  
9 components.

10 Section 3. The Department of Transportation will oversee the enforcement of  
11 this legislation.

12 A) 50% of the funding from Section 1A will go to the Highway  
13 Trust Fund.

14 B) 50% of the funding from Section 1A will be reserved by the  
15 Department of Transportation. State transportation departments  
16 will be able to apply for said funds to repair state-owned  
17 infrastructure.

18 Section 4. This legislation shall be implemented on October 1<sup>st</sup>, 2021.

19 Section 5. All laws in conflict with this legislation are hereby declared null  
20 and void.

## **A Bill to Increase the Penalty for Damaging Federal Property**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1       Section 1:     The legal penalty for damaging any federal property, exceeding \$100 in  
2                       damages, shall be a \$1,000,000 maximum fine, thirty years imprisonment,  
3                       or both. When property damage does not exceed \$100, the legal penalty  
4                       shall be a \$250,000 maximum fine, five years imprisonment, or both.

5       Section 2:     Any federal property shall be defined as any property of the United States  
6                       or an agency or department thereof, or any property being manufactured or  
7                       constructed for the United States or an agency or department thereof.

8       Section 3:     This bill shall go into effect at the beginning of Fiscal Year 2023.

9       Section 4:     The enforcement of this legislation shall be overseen by the Department of  
10                      Justice.

11      Section 5:     All other laws that are in conflict with this new policy shall hereby be  
12                      declared null and void.

## **A Bill to Eliminate Farm Subsidies**

1      BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2      Section 1:      Farm subsidies shall be decreased in increments over the next  
3                              five years until they are completely eliminated.

4      Section 2:      a) Farm subsidies are defined as a government incentive paid to  
5                              agricultural organizations, influencing the cost and supply of commodities  
6                              including but not limited to: wheat, grain, cotton, milk, rice, peanuts,  
7                              sugar, tobacco, and meat.

8                              b) Increments are defined as 20% of current levels each year.

9      Section 3:      This bill shall be implemented at the beginning of fiscal year 2022.

10     Section 4:      The US Department of Agriculture will be responsible for the  
11                              implementation and enforcement of this legislation.

12     Section 5:      All other laws in conflict with this new policy shall be null and void.

## **The Federal Fair Pay to Play Act of 2021**

1     BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2     Section 1:     Postsecondary educational institutions, and athletic organizations with  
3                     authority over intercollegiate athletics, are prohibited from providing a  
4                     student athlete with compensation in relation to the athlete’s name, image,  
5                     or likeness, or preventing a student participating in intercollegiate athletics  
6                     from earning compensation as a result of the use of the student’s name,  
7                     image, or likeness or obtaining professional representation relating to the  
8                     student’s participation in intercollegiate athletics. These groups are also  
9                     prohibited from revoking a student’s scholarship as a result of earning  
10                    compensation or obtaining legal representation as authorized under these  
11                    provisions.

12    Section 2:     “Postsecondary educational institution” is any four-year college or  
13                     university. “Student athlete” a participant in competitive sports sponsored  
14                     by the educational institution in which the student is enrolled.

15    Section 3:     The National Labor Relations Board shall be responsible for  
16                     implementation and enforcement of this legislation.

17    Section 4:     This legislation will be implemented January 1, 2024.

18    Section 5:     All laws in conflict with this new policy are declared null and void.
