

The Medical Enhanced Treatment Act of 2026

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: In light of gaps in healthcare treatment, the United States shall implement
4 a public option healthcare system to increase coverage.

5 Article II: A public option insurance program shall be defined as a government-run
6 healthcare plan that would work alongside and compete with private
7 insurers for individual patient care.

8 Article III: This legislation will take effect on Jan. 1, 2026.

9 Article IV: The United State Department of Health and Human Services shall be
10 tasked with the enforcement and oversight of this legislation.

11 A) A premium of 150 dollars per month would be implemented for
12 patients to pay for the insurance.

13 Article V: All other laws in conflict with this new policy shall be null and void.

A Bill to Shift North Korean Policy to Promote Peace

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: The United States shall adopt a multifaceted approach to reorient its North
4 Korean policy.

5 A) All sanctions on the state of North Korea shall hereby be repealed.

6 B) The United States shall attempt to engage in diplomatic talks with
7 North Korean officials.

8 C) If the aforementioned diplomatic talks with North Korea are found to
9 be successful, the United States shall make available a grant of \$10
10 million dollars for any and all United States-based corporations seeking to
11 build new factories or places of business in North Korea. The North
12 Korean government shall be able to approve or reject any U.S.-based
13 corporation's application for this grant.

14 D) If the aforementioned diplomatic talks with North Korea are found to
15 be unsuccessful, the United States shall reinstate sanctions on North Korea
16 and significantly increase military aid to South Korea, including the
17 deployment of United States soldiers to the country.

18 Article II: Sanctions shall be defined as political or economic penalties imposed by
19 a given nation. Diplomatic talks shall be defined as meetings between
20 foreign officials to address the current political state. The United States
21 will engage in said diplomatic talks primarily with North Korean
22 President Kim Jong Un.

23 Article III: The Department of State shall be responsible for the implementation and
24 enforcement of this legislation, and if the aforementioned peace talks are
25 found to be unsuccessful, the Department of Defense and USAID
26 shall be authorized to significantly increase military aid to South Korea
27 with a maximum budget of 25 billion dollars as well as 10,000 soldiers.

28 Article IV: This legislation will take effect on December 31st of 2025. All laws in
29 conflict with this legislation are hereby declared null and void.

30 Article V: All other laws in conflict with this new policy shall be null and void.

A Bill to Expand the Department of the Navy

BE IT ENACTED BY THIS PALM BEACH CATHOLIC FORENSIC LEAGUE STUDENT CONGRESS

HERE ASSEMBLED THAT:

- ARTICLE I.** A draft of Selected Service members will be conducted for a two-year period in order to bring the enlisted population of the Navy to 300,000 enlisted.
- ARTICLE II.** The United States Department of the Navy will receive an additional \$50 billion annually. The funds will be redistributed from the Department of Agriculture.
- ARTICLE III.** This bill will take effect at the beginning of the 2026 fiscal year, and a House Committee will be established to examine funds for Agriculture.
- ARTICLE IV.** The enforcement of this bill will fall to the US Department of the Navy.
- ARTICLE V.** All laws in conflict with this legislation are hereby declared null and void.

3 Article I: The purpose of this bill is to reform the status quo to eliminate Deep

8 Article III: This legislation will become effective as of FY 2025.

10 legislation.

The Autonomous Machine Tax

- SECTION 1.** In order to ensure the prosperity of the US job market, the following taxes and fees shall be imposed on companies or organizations that remove human jobs in favor of autonomous machinery. Any machinery installed within a business, after Q1 2025, that is intended to replace a human job shall be subject to an initial tax of 10% of the machine's total purchase price. Plus, any machinery installed after Q1 2025 shall be subject to a yearly tax of 5% of the machine's purchase price. Tax remains in effect unless the machine has been removed from service. Should a piece of machinery be removed from service and restored to a human job the company shall receive a tax break of \$1000 per worker hired as a result of the decommissioning of the machine and restoration of a human to that position.
- SECTION 2.** Machinery shall be defined in the context of this bill as any device that fills a job normally requiring a human worker and is capable of operating without human input.
- SECTION 3.** The IRS (Internal Revenue Service) will be responsible for the enforcement and maintenance of this bill.
1. Funds collected from this bill will be used to contribute to Federal unemployment insurance and Social Security.
- SECTION 4.** This legislation will take effect in Q1 2025. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Repeal Obstructive Tariffs on Chinese Electric Vehicles (EVs)

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 **WHEREAS,** China has a booming electric vehicle (EV) industry and developed
4 the public infrastructure necessary to support it; and

5 **WHEREAS,** As countries like the United States and China switch to renewable
6 energy, electric vehicles become a more and more effective method
7 to reduce transportation emissions; and

8 **WHEREAS,** America has levied sanctions on Chinese vehicles and green
9 technology, including a recent 100% tariff on Chinese EVs; and

10 **WHEREAS,** This tactic protects the American auto industry at the expense
11 of global climate progress by thwarting the trade of cheap,
12 competitive, and clean EVs; and

13 **WHEREAS,** Climate change and the accompanying consequences, such as
14 natural disasters and sea level rise, can only be mitigated with
15 cooperative international action; therefore, be it

16 **RESOLVED,** By the Congress here assembled that the US lower tariffs on the
17 import of Chinese electric vehicles, lithium-ion EV batteries, and
18 photovoltaic solar cells down to 10%.

A Bill to Criminalize Involvement of Minors in Media

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
2 assembled that:

3 Article I: All Media Productions involving minors in any capacity will be illegal

4 Article II: **Media Production** will be defined as any content created for public
5 consumption that is designed to generate revenue with intent to distribute
6 including, for example: TV Broadcast/Film Productions, Monetized Social
7 Media Productions, Monetized Music Video Productions, Documentaries,
8 and other properties that can be reasonably considered a media production
9 that would reach an audience for revenue purposes

10 **Minor** will be defined as any person under the age of 18. Parental waivers
11 or Emancipations are not applicable

12 **Any Capacity** is defined as any and all positions on the production,
13 promotion, or acting staff of a production. There are no exceptions
14 for internships or volunteering.

15 Article III: Violations of this statute will incur the following penalties

16 1) If found during production, production is shut down until the situation
17 is rectified and a fine is paid. The fine will be 30% of the production's
18 budget, as determined by a federal audit.

19 2) If found during post production, the production will be blocked from
20 distribution and the company (or entity in the case of small productions)
21 will be fined 100% of the production's budget, as determined by a
22 federal audit

23 3) If found retroactive to the film's distribution, the production will be
24 pulled from distribution and the company/entity will be fined 100% of
the
25 film's budget & total gross, as determined by federal audit

26 Article IV: This legislation will go into effect on January 1st 2030. All productions
27 must be in compliance by this date, with no exceptions for
productions
28 that began earlier than that but ran through that date.

29 Article V: The United States Department of Labor will oversee the enforcement
of 30 this legislation

31 1) The annual budget of the DOL will be increased by 5 Billion to
32 accommodate the costs of annual audits.

33 2) Funds will be paid in part through fines levied against production
34 companies and the rest through funds reappropriated from the
35 Department of Defense

36 Article VI: All productions completed and distributed before January 1st 2030 are
37 exempt from this legislation

38 Article VII: All other laws in conflict with this new policy shall be null and void.

A Bill to Ban Federal Government Leasing of Public Lands and Parks to Private Commercial Enterprises

1 Be it enacted by this palm Beach Ctaholic Forensic League Student Congress here
2 assembled that”:

3 ARTICLE I. The United States government shall ban the leasing of public lands and
4 parks to private commercial enterprises.

5 ARTICLE II. Let the following definitions be used as interpretations:

6 Public lands are defined as land owned and/or managed by federal, state,
7 or local governments.

8 Private commercial enterprises are defined as businesses, corporations, or
9 private entities involved in profit-driven activities.

10 ARTICLE III. The Department of the Interior shall oversee enforcement.

11 The Department shall assume responsibility for developing regulations to
12 categorize public lands and to monitor compliance. This can also include
13 partnerships with other federal, state, and local agencies, as well as non-
14 governmental organizations
15 and community groups, to enhance oversight, including the National Park
16 Service (NPS).

17 ARTICLE IV. This legislation will take effect immediately after passing.

18 ARTICLE V. All laws in conflict with this legislation are hereby declared null and void.

A Bill To Aid the Central American Northern Triangle

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here

2 assembled that:

3 **Article I:** The United States of America shall allocate \$1 billion to reopening the
4 Alliance for Prosperity. The results from the first year will determine
5 contribution in future years.

6 **Article II:** The Alliance for Prosperity is a program that gives financial assistance to
7 Central America's Northern Triangle (consisting of Guatemala, Honduras, &
8 El Salvador), while requiring that each country pledges their their own
9 domestic resources. The alliance focuses on improving well-being through
10 job creation, food programs, stopping crime, reducing corruption, and more,
11 with the underlying goal of reducing immigration to the US.

12 **Article III:** This bill shall be implemented in the fiscal year 2025.

13 **Article IV:** The United States Office of Foreign Assistance will enforce this legislation.

14 **Article V:** All laws in conflict with this legislation are hereby declared null and void.

The Federal Assault Weapons Ban of 2025

1 Be it enacted by this Student Congress here assembled that:

3 Article 1. The “sunset clause” of the 1994 Assault Weapons Ban will be eliminated,
4 and Section 921(a) of Title 18, USC, will be amended to ban the sale,
5 transfer, manufacturing, and importation of assault weapons.

6 Article 2. “Assault weapons” are defined as the following:

7 A. All semiautomatic rifles, pistols or handguns that can accept a
8 detachable magazine and have at least one military feature;

9 B. All semiautomatic rifles, handguns and shotguns that have a fixed
10 magazine with the capacity to accept more than 10 rounds;

11 C. All ammunition feeding devices (magazines, strips, and drums)
12 capable of accepting more than 10 rounds; and

13 D. All AK-, AR- and Thompson-type rifles; all AK-47-, AR-15-,
14 MAC-, Thompson- and UZI-type pistols; all IZHMAISH Saiga 12
15 type shotguns; and all belt-fed semiautomatic firearms.

17 E. A background check on all sales or transfers of a grandfathered
18 assault weapon is also required.

19 Article 3. This law shall take effect July 1, 2025.

20 Article 4. The Bureau of Alcohol, Tobacco, and Firearms (ATF) will enforce this
21 law, coordinating with the Attorney General and Department of Justice.

22 Article 5: All laws in conflict with this legislation are hereby declared null and void.
