## A Bill to Grant Statehood to the District of Columbia

1 Be it enacted by this PBCFL Student Congress here assembled that:

2	Article I.	This bill admits certain portions of Washington, DC as the 51st state.
3	Article II.	The bill defines state as the State of Washington, Douglass Common-
4		wealth. The state shall consist of all of District territory as of enactment of
5		this bill, with specified exclusions for federal buildings and monuments,
6		including the principal federal monuments, the White House, the Capitol
7		Building, the U.S. Supreme Court Building, and the federal executive, leg-
8		islative, and judicial office buildings located adjacent to the Mall and the
9		Capitol Building.
10		District territory excluded from the state shall be known as the Capital and
11		shall be the seat of the federal government.
12	Article III.	This bill permanently increases membership in the House of Representa-

17		Commission to advise the President, Congress, and the executive and leg-

## The Federal Fair Pay to Play Act of 2021

4		student athlete with compensation in relation to the athlete's name, image,

9		prohibited from revoking a student's scholarship as a result of earning

13		university. "Student athlete" a participant in competitive sports sponsored
14		by the educational institution in which the student is enrolled.
15	Article III:	This legislation will be implemented January 1, 2024.
16	Article IV:	The National Labor Relations Board shall be responsible for
17		implementation and enforcement of this legislation.
