

## **The Police Demilitarization Act of 2025**

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here  
2 assembled that:

3 Article I: The 1122 and 1033 Programs shall be abolished.

4 Article II: The 1122 Program is defined as the Department of Defense program based  
5 on Section 1122 of the 1994 National Defense Authorization Act, which  
6 established the authority of the state and local governments to purchase  
7 law enforcement equipment through federal procurement channels. The  
8 1033 Program is defined as the Department of Defense program based on  
9 Section 1033 of the 1997 National Defense Authorization Act, which  
10 authorizes the Department of Defense to transfer excess military  
11 ent properly to state and local law enforcement authorities.

12 Article III: The Department of Defense (DOD) and Department of Justice (DOJ) shall  
13 be tasked with implementation and oversight of this legislation.

14 Article IV: This legislation will take effect on January 1, 2025.

15 Article V: All other laws in conflict with this new policy shall be null and void.

## **A Resolution to Relocate the Futenma Base to Benefit the Japanese People**

1       Whereas:       The United States Marine Corps Air Station Futenma, located in Okinawa,  
2                       Japan, is causing numerous negative effects toward local Japanese  
3                       civilians; and

4       Whereas:       Japan has increased its budget for its military to counter aggression from  
5                       its neighbors, including China; and

6       Whereas:       Japan has expressed its opposition toward the Futenma Base and has  
7                       offered off-shore alternative locations; and

8       Whereas:       The United States and the Philippines have been negotiating on a deal to expand  
9                       U.S. military presence in the Philippines; and

10      Whereas:       The Senkaku Islands are uninhabited, allowing for a base to flourish in a non-  
11                      civilian environment in the East China Sea; and

12      Whereas:       The People’s Republic of China has pushed for dominance over the Senkaku  
13                      Islands due to an abundance of resources; and

14      Whereas:       Between expansion to the Philippines and the Senkaku islands, the United States  
15                      will have a grasp on Chinese aggression targeted toward Taiwan; therefore, be it

16      RESOLVED, by the Palm Beach Catholic Forensic League Student Congress here assembled  
17                      that: Congress will close down the Futenma Base; and, be it

18      FURTHER RESOLVED, by the Palm Beach Catholic Forensic League Student Congress here  
19                      assembled that the United States will continue to increase the United States’  
20                      military presence in the Philippines; and, be it

22      FURTHER RESOLVED, by the Palm Beach Catholic Forensic League Student Congress here  
23                      assembled that the United States open a base in the Senkaku Islands.

**A Bill to Ban the Importation of  
Brazilian Beef**

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here  
2 assembled that:

3 Article I: A ban will be placed on the importation of Brazilian beef into  
4 the United States to ensure product safety and protect the health of  
5 American consumers.

6 Article II: Product safety refers to the meat products imported from Brazilian  
7 sources.

8 Article III: This bill will go into effect on June 1, 2025.

9 Article IV: The United States Department of Commerce in conjunction with the  
10 United States Department of Agriculture will oversee the implementation  
11 and enforcement of this bill.

12 A) The USDA will provide a subsidy of up to \$1,000,000  
13 to eligible meat farms (with feedlots under 1000) upon  
14 implementation to meet the demand for beef.

15 Article V: All other laws in conflict with this new policy shall be null and void.

# **A Resolution to Adopt a “No First Use” Nuclear Policy**

1       Whereas:       Tensions between the United States and China have escalated in recent  
2                       years, leading to potential threats of nuclear conflict; and  
3       Whereas:       China maintains a “No First Use” nuclear policy, declaring that it will not  
4                       use nuclear weapons unless first attacked by nuclear weapons; and  
5       Whereas:       the United States has not done the same, contributing to geo-political  
6                       uncertainties, which increase the risk of nuclear escalation; and  
7       Whereas:       the potential use of nuclear weapons as a first strike option could lead to  
8                       catastrophic consequences causing loss of human lives, environmental  
9                       destruction, and destabilization of global security; and  
10      Whereas:       the adoption of a No First Use Nuclear Policy is essential to reduce the  
11                      likelihood of nuclear war and promote strategic stability; and  
12      Whereas:       Congress has the responsibility to safeguard the security and well-being of  
13                      the American people and uphold the principles of peace and diplomacy;  
14      Therefore:      be it resolved by this Palm Beach Catholic Forensic League Student  
15                      Congress assembled here that the United States should adopt a No First Use  
16                      Nuclear Policy

## **A Bill to Legalize Private Sale of Human Organs**

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here  
2 assembled that:

3 Article I: Sale of human organs by their owner to consumers will now be legal

4 Article II: Human Organs is defined as, “a group of tissues in a living organism that  
5 have been adapted to perform a specific function.”

6 Article III: Any 25 year old human may elect to sell their organs to a willing  
7 purchaser as long as it meets the following requirements:

- 8 1) The organ cannot be one whose absence causes direct death
- 9 2) All sales must be overseen and approved by a new executive  
10 agency with screenings for any physical, mental, or genetic  
11 conditions that may alter the quality of organs or create a lack of  
12 complete consent

13 Each US State will receive categorial grants of 5 million dollars per year  
14 to establish satellite outposts in their state to process requests

15 The Congress will appropriate 150 million dollars for the creation of “The  
16 US Department of Organ Sales.”

17 The penalty for unregistered sale of organs will be classified as a human  
18 trafficking crime, with a mandatory minimum prison sentence of 20 years

19 Article IV: The US Department of Organ Sales will oversee the enforcement of this  
20 legislation. This legislation will go into effect January 20<sup>th</sup> 2025

21 Article V: All other laws in conflict with this new policy shall be null and void.

## **A Bill to Create the Federal Digital Platform Commission**

1 Be it enacted by this Palm Beach Catholic Forensic League Congress here assembled  
2 that:

3 Article I: A Federal Digital Platform Commission will be created to oversee the

12 Article IV: The Department of Justice and Federal Trade Commission shall oversee  
13 the implementation of this legislation.

14 A) The House of Representatives and Senate shall include funding the  
15 Federal Digital Platform Commission in their 2025 appropriations  
16 budgets.

17 Article V: All laws in conflict with this legislation are hereby declared null and void.

# **A Bill to Allocate Funding for Pre-Secondary Athletic Departments**

1 *Be it enacted by this Palm Beach Catholic Forensic League Student Congress here*

2 *assembled that:*

3 **Article I:** Athletic departments in pre-secondary level education have been  
4 heavily under funded, taking away from the opportunities of students to  
5 better themselves physically and mentally. Hence, this bill will allocate  
6 funding for schools from property taxes as a means to allow each school  
7 to have equal opportunity. 10% of all property taxes collected shall be  
8 delivered to the State Boards of Education, which will then equally  
9 distribute these funds to all public pre-secondary institutions for the  
10 exclusive use of funding athletic programs.

11 **Article II:** Pre-secondary education shall be defined as the primary, intermediate and  
12 high school levels of education.

13 Property tax is largely utilized to fund schools. Hence, the property tax  
14 collected by the state should equally, in percentage, go to each school to  
15 guarantee equal opportunities.

16 **Article III:** This bill will become effective January 1, 2025.

17 **Article IV:** The Department of Education will oversee the equal distribution of funds.

18 **Article V:** All other laws that are in conflict with this new policy shall hereby be  
19 declared null and void.

## **A Bill to Eliminate the Filibuster and Cloture**

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here

2 assembled that:

3 Article I: The legislative branch on all levels of government (federal, state, and  
4 local) shall eliminate and prohibit the usage of filibuster and cloture in  
5 the senate, being that they function simultaneously.

6 Article II: The filibuster refers to the verbal and silent action designed to prolong  
7 debate and delay or prevent the voting on a bill, resolution, or amendment.

8 The cloture is to be defined as the rule permitting a two-thirds majority to  
9 end a filibuster.

10 Article III: This bill is to become effective immediately upon passage.

11 Article IV: All laws in conflict with this legislation are hereby declared null and void.

10 Article IV: This bill shall be enforced by the United States Government Publishing  
11 Office.

12 Article V: All other laws in conflict with this bill shall be null and void.

A Bill to Grant Released Felons the Right to Vote

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here  
2 assembled that:

3 Article I: Those with felony convictions shall be granted the right to vote after their  
4 sentence has been served, thus eliminating the disenfranchisement of these  
5 individuals.

6 Article II: A felony conviction shall be defined as any offense punishable by  
7 imprisonment for more than one year. Disenfranchisement shall be defined  
8 as being deprived of the right to vote.

9 Article III: This bill will become effective immediately upon passage.

10 Article IV: The Federal Elections Commission and the United States Department of  
11 Treasury shall work alongside state and local governments to oversee the  
12 passing of this  
13 legislation.

14 Article V: All other laws in conflict with this new policy shall be null and void.

## **A Bill to Support Policing in Small Towns**

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here  
2 assembled that:

3 Article I: \$125 million shall be allocated to help establish and support police  
4 departments in small towns. This money will go towards establishing or  
5 maintaining local police departments in small towns lacking sufficient  
6 police resources.

7 Article II: A “small town” is defined as an area with a population of 2,500 or fewer,  
8 and is more than 20 miles from any incorporated municipality. “Lacking  
9 sufficient police resources” is defined as any Law Enforcement Agency  
10 with insufficient funding, resources, or personnel to adequately handle  
11 crime that occurs in their jurisdiction.

12 Article III: This bill shall go into effect July 1, 2024

13 Article IV: The Department of Justice shall be tasked with enforcing this bill

14 a) The Department of Justice shall create a board that will be  
15 tasked with reviewing crime statistics and extending  
16 funding offers to small towns.

17 b) Small Towns may file a request for funds via the  
18 Department of Justice’s board.

19 Article V: All other laws in conflict with this new policy shall be null and void.

## **A Bill to Ban Unpaid Internships**

1 Be it enacted by this Palm Beach Catholic Forensic League Student Congress here  
2 assembled that:

3 Article I: The Fair Labor Standards Act (29 USC 201-209) shall be amended by  
4 adding the following to section 206 part (b)(i), "...which includes all labor,  
5 regardless of primary beneficiary status."

6 Article II: All definitions shall be as listed in 29 USC 203, with the addition of the  
7 verbiage, "Primary beneficiary status shall be defined as the party by  
8 which the employment benefits greatest."

9 Article III: This bill shall be implemented on January 1, 2025.

10 Article IV: Any and all agencies tasked with the original implementation of the  
11 Fair Labor Standards Act will be tasked with the continued  
12 implementation of this legislation.

13 A) This includes the U.S. Department of Labor and its other  
14 relevant offices

15 B) All agencies with oversight over the legislation shall be  
16 authorized to penalize any and all employers in violation of this  
17 law in accordance with any relevant parts of 29 USC 206.

18 Article V: All other laws in conflict with this new policy shall be null and void.
