4		recidivism. All said prisons must meet a nutritional requirement for meals
5		and must provide rehabilitation services in the prison twice a week. Each
6		prison shall be in charge of hiring the licensed professionals
7		that will be providing the rehabilitation services.
8	Article II:	"Nutritional requirements" will be based on the amount of average calorie
9		intake, mineral and nutrient composition, based on the standards of the
10		U.S. National Academy of Medicine. "Rehabilitation" shall be defined as
11		programs such as therapy and skill building workshops overseen by
12		licensed professionals to reduce the rates of recidivism.
13	Article III:	This bill will become effective January 1, 2025.
14	Article IV:	The U.S. Department of Justice's Bureau of Prisons (BOP) shall allocate
15		1 billion dollars and oversee the standards of rehabilitation. The Food and
16		Drug Administration shall oversee the nutritional standards for each
17		prison.
